1. 1487330 Ontario Inc. (Report No. 5502)

Anthanasia-Nanci Mantis, President

Applicant for Renewal of Motorized Refreshment Vehicle Licence Nos.:

V15-3591845, V15-3591851, V15-3360540 and V15-3360543

AND

Ms. Anthanasia-Nanci Mantis

Holder of Non-Motorized Refreshment Vehicle Licence No. V27-3130129.

DECISION:

The Tribunal approved the following joint recommendation:

1487330 Ontario Inc.'s motorized refreshment vehicle licence Nos. V15-3591845, V15-3591851, V15-3360540 and V15-3360543 will be renewed, effective immediately, and the following conditions will be placed on these licences and Ms. Anthanasia-Nanci Mantis' non-motorized refreshment vehicle licence No. V27-3130129:

- (1) immediately upon the 4 licences being renewed, all five (5) licences will be suspended until proof is provided to Municipal Licensing and Standards that either the fines have been paid in full or the court has extended the time for payment;
- (2) during the probationary period, if the corporation or Ms. Mantis incur any bylaw or criminal charges or convictions, Municipal Licensing and Standards must be notified of these, in writing, within five (5) business days; and
- (3) during the probationary period if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5502 and any updating material may be brought back before the Tribunal for a full hearing.

The Tribunal ordered that all five licences and photo cards must be surrendered to Municipal Licensing and Standards by 12:00 noon today (April 5, 2012).

DECISION:

The Tribunal extended taxicab owner's licence Nos. V02-4071855, V02-4071854, V02-4071853, V02-4071851, V02-4071850, V02-4071849, V02-4071848 and V02-4071847 for plate Nos. 318, 319, 873, 1186, 1210, 1503, 1880 and 2313 in the Estate of Bert Bainerman until July 6, 2012 and ordered that the licences will be suspended at 8:30 a.m. on May 1, 2012 and until these are disposed of.

Today's Tribunal panel seized itself of this matter in case it is brought back before the Tribunal.

The Tribunal ordered the Estate of Bert Bainerman to surrender the licence plates to Municipal Licensing and Standards by 8:30 a.m. on May 1, 2012.

The Tribunal approved the following joint recommendation:

Wei Hu's holistic practitioner's licence No. T30-3367119 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) during the probationary period, if Ms. Hu incurs any bylaw or criminal charges or convictions, she must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (3) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5527 and any updating material may be brought back before the Tribunal for a full hearing.
