**TORONTO LICENSING TRIBUNAL: May 3, 2012****Summary of Decisions****D. Peacock / M. Borer / D. Hall**

**1. Hussein Elmi** (*Report No. 5719*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3839918.

**DECISION:**

The Tribunal approved the following joint recommendation:

Hussein Elmi's taxicab driver's licence No. D01-3839918 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) prior to each of the next two renewals of the licence, Mr. Elmi must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Elmi incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5719 and any updating material may be brought back before the Tribunal for a full hearing.

**2. Estate of Sandra Mandronis** (*Report No. 5842*)

Peter Mandronis, Estate Trustee

Holder of Taxicab Owner's Licence Nos. V02-4068187, V02-4068190, V02-4068191 and V02-4068192, for Plate Nos. 40, 96, 306 and 439.

**DECISION:**

The Tribunal extended taxicab owner's licence Nos. V02-4068187, V02-4068190, V02-4068191 and V02-4068192, for Plate Nos. 40, 96, 306 and 439 in the Estate of Sandra Mandronis for a period of two months (up to July 2, 2012) to allow time for the plates to be sold.

Today's Tribunal panel seized itself of this matter in case it is brought back before the Tribunal.

3. **Estate of Yan Groisman** (*Report No. 5805*)  
Divad Groisman, Trustee  
Holder of Taxicab Owner's Licence No. V02-4179054, for Plate No. 2946.

**DECISION:**

Report No. 5805 was withdrawn by Municipal Licensing and Standards as the plate has already been sold.

4. **Dawit Fikremichael** (*Report No. 5779*)  
Applicant for a Taxicab Driver's (Lapsed) Licence (Application No. B185348).

**DECISION:**

The Tribunal denied Dawit Fikremichael's application (No. B185348) for a taxicab driver's licence.

5. **Saeed Ayerman** (*Report No. 5401*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-2020623.

**DECISION:**

The Tribunal adjourned this matter to May 31, 2012, *peremptory* to Mr. Ayerman with the continuation of the existing suspension.  
(Mr. Ayerman did not attend today's hearing.)

6. **Terry James Moore** (*Report No. 5731*)  
Applicant for a Tow Truck Driver's Licence (Application No. B184330).

**DECISION:**

The Tribunal granted Terry James Moore's application (No. B184330) for a tow truck driver's licence, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Moore must provide to Municipal Licensing and Standards, at his own expense, his updated criminal record check;

- (3) during the probationary period, if Mr. Moore incurs any new charges or convictions under the *Criminal Code*, or the *Controlled Drug and Substances Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5731 and any updating material may be brought back before the Tribunal for a full hearing.
