# TORONTO LICENSING TRIBUNAL June 7, 2012 Summary of Decisions

1. Muhammad Ahsan (Report No. 5811)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3729732.

#### **DECISION**:

The Tribunal granted the renewal of Muhammad Ahsan's taxicab driver's licence No. D01-3729732, effective immediately, without conditions.

2. Michael Marier (Report No. 5837)

Applicant for a Building Renovator's Licence (Application No. B290866).

#### **DECISION**:

The Tribunal approved the following joint recommendation:

Michael Marier's application (No. B290866) for a building renovator's licence will be granted, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of one (1) year;
- (2) prior to the next renewal of the licence, Mr. Marier must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record check;
- (3) during the probationary period, if Mr. Marier incurs any new charges or convictions under the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (4) during the probationary period, if any new *Criminal Code* charges or convictions raise a concern to Municipal Licensing and Standards, those matters and report No. 5837 and any updating material may be brought back before the Tribunal for a full hearing.

# 3. Navjot Mahar (Report No. 5702)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3838511.

#### **DECISION:**

The Tribunal approved the following joint recommendation:

Navjot Mahar's taxicab driver's licence No. D01-3838511 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Mahar must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Mahar incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5702 and any updating material may be brought back to the Tribunal for a full hearing.

## 4. William Seifert (Report No. 5812)

Applicant for Renewal of Tow Truck Driver's Licence No. D09-3846061.

## **DECISION:**

The Tribunal approved the following joint recommendation:

William Seifert's tow truck driver's licence No. D01-383511 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be suspended for a period of one (1) day commencing June 8, 2012;
- (2) immediately upon being reinstated, the licence will be placed on probation for a period of two (2) years;
- (3) prior to each of the next two renewals of the licence, Mr. Seifert must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

- (4) during the probationary period, if Mr. Seifert incurs any new charges or convictions under the *Highway Traffic Act* or the Toronto Municipal Code, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (5) during the probationary period, if Municpal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5812 and any updating material may be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Seifert to surrender his licence and photo card I.D. to Municipal Licensing and Standards by 12:00 noon on June 8th, 2012.

# 5. Efetobo Ono (Report No. 5627)

Applicant for a Taxicab Driver's Licence (Application No. B071967).

#### **DECISION:**

The Tribunal approved the following joint recommendation:

Efetobo Ono's application (No. B071967) for a taxicab driver's licence will be granted, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Ono must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record and his criminal record check;
- (3) during the probationary period, if Mr. Ono incurs any new charges or convictions under the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (4) During the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5627 and any updating material may be brought back to the Tribunal for a full hearing.

## 6. Mohammad Rizwan Raja (Report No. 5628)

Applicant for a Taxicab Driver's Licence (Application No. B177967).

## **DECISION:**

The Tribunal adjourned this matter to be rescheduled by the Administrator.
