
TORONTO LICENSING TRIBUNAL: July 26, 2012
Summary of Decisions

1. Sabbirahmed Jogiyat (*Report No. 5703*)

Applicant for a Hawker Pedlar with Motor Vehicle Licence (Application No. B182018).

DECISION:

The Tribunal adjourned this matter to September 27, 2012, *peremptory* to Mr. Jogiyat.

2. Dino Gonzales (*Report No. 5623*)

Applicant for a Tow Truck Driver's Licence (Application No. B177577).

DECISION:

The Tribunal granted Dino Gonzales' application (No. B177577) for a tow truck driver's licence, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of five (5) years;
- (2) prior to each of the next five renewals of the licence, Mr. Gonzales must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record and his criminal record;
- (3) during the probationary period, if Mr. Gonzales incurs any new charges or convictions under the Provincial Statutes, the *Criminal Code*, the *Highway Traffic Act*, or the *Toronto Municipal Code* he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions under the Provincial Statutes, the *Criminal Code*, the *Highway Traffic Act*, or the *Toronto Municipal Code*, those matters and report No. 5623 and any updating material may be brought back before the Tribunal for a full hearing.

3. Romulo Merchan (*Report No. 5695*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-0114171.

DECISION:

The Tribunal adjourned this matter to September 27, 2012.

4. **Pietro Leone** (*Report No. 5803*)

Applicant for Renewal of Public Garage Licence No. B68-0232676.

DECISION:

The Tribunal granted the renewal of Pietro Leone's public garage licence No. B68-0232676, effective immediately, without conditions.

5. **Mistre-Tegegn Gebre-Kidan** (*Report No. 5593*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3729214.

DECISION:

With Tribunal Member Ken Chan dissenting, the Tribunal granted the renewal of Mistre-Tegegn Gebre-Kidan's taxicab driver's licence No. D01-3729214, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be suspended for a period of five (5) days commencing Friday, July 27, 2012;
- (2) immediately upon being reinstated, the licence will be placed on probation for a period of three (3) years;
- (3) prior to each of the next three renewals of the licence, Mr. Gebre-Kidan must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Gebre-Kidan incurs any new charges or convictions under the *Highway Traffic Act* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions under the *Highway Traffic Act* or the *Toronto Municipal Code*, those matters and report No. 5593, and any updating material, can be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Gebre-Kidan to surrender his licence and photo card to Municipal Licensing and Standards on Friday, July 27, 2012 by 9:00 a.m. Mr. Gebre-Kidan can pick up his licence and photo card on Wednesday, August 1, 2012 after 9:00 a.m.
