TORONTO LICENSING TRIBUNAL: August 9, 2012 Summary of Decisions

1. Joe Appiah (*Report No. 5826*) Holder of Taxicab Driver's Licence No. D01-0222412.

DECISION:

The Tribunal adjourned this matter to October 25, 2012, *peremptory* to Mr. Appiah. (Mr. Appiah did not attend today's hearing.)

2. Imran Tufail (*Report No. 5756*) Applicant for Renewal of Taxicab Driver's Licence No. D01-3481615.

DECISION:

The Tribunal approved the following joint recommendation:

Imran Tufail's taxicab driver's licence No. D01-3481615 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Tufail must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Tufail incurs any charges or convictions under the *Highway Traffic Act*, or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5756, and any updating material, may be brought back before the Tribunal for a full hearing.

3. Lawrence Duah-Amankwah (Report No. 5749)

Applicant for Renewal of Taxicab Driver's Licence No. D01-1010261.

DECISION:

The Tribunal dismissed the application. (Mr. Duah-Amankwah did not attend today's hearing.)

The Tribunal ordered that Mr. Duah-Amankwah surrender his licence and photo card to Municipal Licensing and Standards.

4. Whitfield Belasco (Report No. 5819)

Applicant for Renewal of Taxicab Driver's Licence No. D01-2019731.

DECISION:

The Tribunal adjourned this matter to September 6, 2012, *peremptory* to Mr. Belasco.

The Tribunal ordered staff to re-send the hearing material to Mr. Belasco and, if possible, request Mr. Belasco to pick up the material from the Tribunal Licensing office.

5. Kulendranathan Sellamuthu *(Report No. 5650)* Applicant for Renewal of Taxicab Driver's Licence No. D01-2020028.

DECISION:

The application was withdrawn by the applicant, Mr. Sellamuthu.

The Tribunal ordered Mr. Sellamuthu to attend at the Municipal Licensing and Standards office to make a declaration that his taxicab driver's licence and photo card are lost.
