**TORONTO LICENSING TRIBUNAL: August 16, 2012**  
**Summary of Decisions**  
**M. Borer / S. Agrawal / D. Hall**

1. **Mohamad Pahlavani Farahani** (*Report No. 5894*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3845770.

**DECISION:**

The Tribunal approved the following joint recommendation:

Mohamad Pahlavani Farahani's taxicab driver's licence No. D01-3845770 will be renewed, effective immediately, provided that all requirements under Chapter 545 of the *Toronto Municipal Code* have been complied with, subject to the following conditions:

- (1) the licence will be placed on probation for a period of two (2) years commencing August 16, 2012;
- (2) prior to each of the next two renewals of the licence, Mr. Farahani must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (3) during the probationary period, if Mr. Farahani incurs any charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if there are any *Highway Traffic Act* charges or convictions of concern to Municipal Licensing and Standards, those matters and Report 5894, and any updating material, shall be brought back before the Tribunal for a hearing.

**DECISION:**

The Tribunal approved the following joint recommendation:

- 1) 1258728 Ontario Ltd., operating as Café Le Monde ("Café Le Monde"), admits to the fact contained in Report 5913, dated August 3, 2012 (the "Report"), paragraph 3, namely that he has been charged criminally as indicated in the Report, subject to bail conditions as specified, which criminal charges have not yet been tried;
- 2) Café Le Monde's Eating Establishment Licence shall be subject to the following conditions:
  - a) Mr. Mohammad Reza Arabi is prohibited from entering the premises of Café Le Monde at 5418 Yonge St. except in the direct company of his surety, Fatemeh Alikandeh, so long as Mr. Arabi's Recognizance of Bail dated July 27, 2012 is in force ;
  - b) The condition described in paragraph a) shall be printed on Café Le Monde's Eating Establishment Licence;
  - c) The Applicant shall notify the Municipal Licensing and Standards Division at the City of Toronto ("MLS") in writing within three (3) business days of any changes to Mr. Arabi's bail conditions so long as the criminal charges outlined in paragraph 1 remain outstanding;
  - d) the Applicant shall notify MLS in writing within three (3) business days of any charges or convictions against Mr. Arabi under the *Criminal Code* so long as the criminal charges outlined in paragraph 1 remain outstanding; and
  - e) any changes to the bail conditions or any convictions or charges under the *Criminal Code* against Mr. Arabi that are of concern to MLS shall be brought forward along with Report Number 5913 for a hearing before the Toronto Licensing Tribunal so long as the criminal charges outlined in paragraph 1 remain outstanding.

**3. Seyed Javad Hosseiny-Haghigi (Report No. 5855)**  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3503194.

**DECISION:**

The Tribunal approved the following joint recommendation:

Seyed Javad Hosseiny-Haghigi's taxicab driver's licence No. D01-3503194 will be renewed, effective immediately, provided that all requirements under Chapter 545 of the *Toronto Municipal Code* have been complied with, subject to the following conditions:

- (1) the licence will be suspended for a period of three (3) days commencing August 17, 2012;

- (2) the licence will be placed on probation for a period of three (3) years commencing August 16, 2012;
- (3) prior to each of the next three renewals of the licence, Mr. Farahani must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (4) during the probationary period, if Mr. Farahani incurs any charges or convictions under the *Highway Traffic Act* or the *Compulsory Automobile Insurance Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if there are any *Highway Traffic Act* charges or convictions of concern to Municipal Licensing and Standards, those matters and Report 5855, and any updating material, shall be brought back before the Tribunal for a hearing.

4. **Mahmood Zangeneh** (*Report No. 5775*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-2002345.

**DECISION:**

The Tribunal denied the renewal of Mahmood Zangeneh's taxicab driver's licence No. D01-2002345.

5. **Pushpinder Chopra** (*Report No. 5793*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-0155844.

**DECISION:**

The Tribunal adjourned this matter to October 11, 2012, *peremptory* to Mr. Chopra.
