
TORONTO LICENSING TRIBUNAL: September 20, 2012
Summary of Decisions

1. **Sher Ahmed Khan** (*Report No. 5852*)
Applicant for Renewal of Driving Instructor's Licence No. V11-3951873.

The Tribunal adjourned this matter to October 4, 2012.

2. **Seyed Yaghoob Mohseni Mofidi** (*Report No. 5763*)
Applicant for a Renewal of Taxicab Driver's Licence No. D01-3117254.

The Tribunal renewed Seyed Yaghoob Mohseni Mofidi's taxicab driver's licence No. D01-3117254, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Mofidi must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Mofidi incurs any new *Highway Traffic Act* charges or convictions, including convictions on any charges still pending, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5763, and any updating material, may be brought before the Tribunal for a full hearing.

3. **Zahidul Islam Chowdhury** (*Report No. 5857*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3472551.

The Tribunal approved the following joint recommendation:

Zahidul Islam Chowdhury's taxicab driver's licence No. D01-3472551 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Chowdhury must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Chowdhury incurs any new *Highway Traffic Act* charges or convictions, including any convictions on charges still pending, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5857, and any updating material, may be brought before the Tribunal for a full hearing.

4. Zameer Abbas (*Report No. 5397*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3719225.

The Tribunal renewed Zameer Abbas' taxicab driver's licence No. D01-3719225, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Abbas must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Abbas incurs any new *Highway Traffic Act* or *Toronto Municipal Code* charges or convictions, including convictions on any charges still pending, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5397, and any updating material, may be brought before the Tribunal for a full hearing.

5. Shaun William Gill (*Report No. 5881*)

O/A Low Cost Roofing

Applicant for a Building Renovator's Licence (Application No. B293889).

The Tribunal adjourned this matter to October 11, 2012, *peremptory* to Mr. Gill. (Mr. Gill failed to attend today's hearing.)

6. Henry Imadojemo (*Report No. 5824*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3105160.

The Tribunal approved the following joint recommendation:

Henry Imadojemo's taxicab driver's licence No. D01-3105160 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years from September 20, 2012;
- (2) prior to each of the next three renewals of the licence, Mr. Imadojemo must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record and his criminal record check;
- (3) during the probationary period, if Mr. Imadojemo incurs any new *Highway Traffic Act* or *Criminal Code* charges or convictions, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new *Highway Traffic Act* or *Criminal Code* charges or convictions, those matters and report No. 5824, and any updating material, may be brought before the Tribunal for a full hearing.
