**TORONTO LICENSING TRIBUNAL: October 11, 2012****Summary of Decisions****D. Hall / M. Borer / D. Peacock**

**1. Estate of Geza Deutsch (Report No. 5939)**

Julianna Deutsch, Estate Trustee

Holder of Taxicab Owner's Licence Nos. V02-4185861 and V02-4185862,

For Plate Nos. 1951 and 3134.

**DECISION:**

The Tribunal:

- (1) adjourned this matter to a date to be scheduled by Tribunal staff when a Hungarian interpreter is in attendance; and
- (2) extended taxicab owner's licence Nos. V02-4185861 and V02-4185862, for plate Nos. 1951 and 3134 in the Estate of Geza Deutsch, in the interim, on condition that all renewal charges for the licences are paid.

**2. Aaron Anand Mungalchety (Report No. 5854)**

Applicant for Renewal of Taxicab Driver's Licence No. D01-3846214.

**DECISION:**

The Tribunal approved the following joint recommendation:

Aaron Anand Mungalchety's taxicab driver's licence No. D01-3846214 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be suspended for one day (24 hours) commencing October 11, 2012;
- (2) the licence will be placed on probation for a period of three (3) years commencing October 11, 2012;
- (3) prior to each of the next three renewals of the licence, Mr. Mungalchety must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

- (4) during the probationary period, if Mr. Mungalchety incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5854, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Mungalchety to surrender his licence and photo card to Municipal Licensing and Standards immediately.

**3. Randolph Richards** (*Report No. 5877*)

Applicant for a Hawker Pedlar with Motor Vehicle Licence (Application No. B186525).

**DECISION:**

The Tribunal granted Randolph Richards' application (No. B186525) for a hawker pedlar with motor vehicle licence, effective immediately.

**4. Sivakumar Visuvalingam** (*Report No. 5888*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3947438.

**DECISION:**

The Tribunal approved the following joint recommendation:

Sivakumar Visuvalingam's taxicab driver's licence No. D01-3947438 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of two (2) years commencing October 11, 2012;
- (2) prior to each of the next two renewals of the licence, Mr. Visuvalingam must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Visuvalingam incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5888, and any updating material, shall be brought back before the Tribunal for a full hearing.

5. **Pushpinder Chopra** (*Report No. 5793*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-0155844.

**DECISION:**

The Tribunal denied Pushpinder Chopra's application for renewal of his taxicab driver's licence No. D01-0155844.

6. **Mohamed Suleiman Hussein** (*Report No. 5856*)  
Applicant for a Taxicab Driver's Licence (Application No. B180589).

**DECISION:**

The Tribunal deemed Mohamed Suleiman Hussein's application (No. B180589) as being abandoned.  
(Mr. Hussein failed to attend today's hearing.)

7. **Shaun William Gill** (*Report No. 5881*)  
o/a Low Cost Roofing  
Applicant for a Building Renovator's Licence (Application No. B293889).

**DECISION:**

The Tribunal granted Shaun William Gill's application (No. B293889) for a building renovator's licence, effective immediately, without conditions.
