
TORONTO LICENSING TRIBUNAL: December 13, 2012
Summary of Decisions

Items 1 to 6 are Pre-Hearing Matters

1. **Sibtain Akhtar** (*Report No. 5739*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3596126.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Sibtain Akhtar's taxicab driver's licence No. D01-3596126 will be renewed, effective immediately, subject to the following conditions:

- (1) a three (3) day suspension to Sibtain Akhtar's taxicab driver's licence No. D01-3596126, to commence on December 13, 2012;
- (2) the licence will be placed on probation for a period of three (3) years to commence on December 13, 2012;
- (3) prior to each of the next three renewals of the licence, Mr. Akhtar must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Akhtar incurs any new charges or convictions under the *Highway Traffic Act*, *Compulsory Automobile Insurance Act* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5739, and any updating material, shall be brought back before the Tribunal for a full hearing.

2. **Gabriel Agbonigiarhuoyi** (*Report No. 5396*)
(also known as Gabriel Agbons)
Applicant for Renewal of Taxicab Driver's Licence No. D01-2016881.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Gabriel Agbonigiarhuoyi's taxicab driver's licence No. D01-2016881 will be renewed, effective immediately, subject to the following conditions:

- (1) a three (3) day suspension to Gabriel Agbonigiarhuoyi's taxicab driver's licence No. D01-2016881, to commence on December 13th, 2012;
- (2) the licence will be placed on probation for a period of three (3) years to commence on December 13th, 2012;
- (3) prior to each of the next three renewals of the licence, Mr. Agbonigiarhuoyi must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving record and criminal record;
- (4) during the probationary period, if Mr. Agbonigiarhuoyi incurs any new charges or convictions under the *Highway Traffic Act*, *Criminal Code of Canada* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5396, and any updating material, shall be brought back before the Tribunal for a full hearing.

3. Zahir Abbas (*Report No. 5898*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3500913.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Zahir Abbas' taxicab driver's licence No. D01-3500913 will be renewed, effective immediately, subject to the following conditions:

- (1) a two (2) day suspension to Zahir Abbas' taxicab driver's licence No. D01-3500913, to commence on December 13th, 2012;
- (2) the licence will be placed on probation for a period of three (3) years to commence on December 13th, 2012;
- (3) prior to each of the next three renewals of the licence, Mr. Abbas must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Abbas incurs any new charges or convictions under the *Highway Traffic Act*, *Criminal Code of Canada* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and

- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5898, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. **Van Nhan Nguyen** (*Report No. 5887*)
Applicant for Renewal of Ambassador Taxicab Owner's Licence No. V02-3364923.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Van Nhan Nguyen's Ambassador taxicab owner's licence No. V02-3364923 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on December 13th, 2012;
- (2) prior to each of the next three renewals of the licence, Mr. Nguyen must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Nguyen incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5887, and any updating material, shall be brought back before the Tribunal for a full hearing.

5. **Zafar Ullah Choudhary** (*Report No. 5903*)
Applicant for Renewal of Taxicab Owner's Licence No. V02-3950811.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Zafar Ullah Choudhary's taxicab owner's licence No. V02-3950811 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on December 13th, 2012;

- (2) prior to each of the next three renewals of the licence, Mr. Choudhary must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Choudhary incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5903, and any updating material, shall be brought back before the Tribunal for a full hearing.

6. **Ali Hussein Isse** (*Report No. 5891*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3594233.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Ali Hussein Isse's taxicab driver's licence No. D01-3594233 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on December 13th, 2012;
- (2) prior to each of the next three renewals of the licence, Mr. Isse must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Isse incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5891, and any updating material, shall be brought back before the Tribunal for a full hearing.

7. **Nazaret Britsian** (*Report No. 5885*)
Applicant for Renewal of Tow Truck Driver's Licence No. D09-3607450.

DECISION:

The Tribunal adjourned this matter to January 31, 2013, *peremptory* to Mr. Britsian.
