

TORONTO LICENSING TRIBUNAL: January 17, 2013**Summary of Decisions****K. Chan / D. Peacock / T. Yao**

1. Ahmad Muntasir Mamun (Report No. 5889)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3948117.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Ahmad Muntasir Mamun's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on January 17, 2013;
- (2) prior to each of the next three renewals of the licence, Mr. Mamun must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Mamun incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5889, and any updating material, shall be brought back before the Tribunal for a full hearing.

2. Estate of Bruce Edward Bell (Report No. 5997)

Holder of Taxicab Owner's Licence No. V02-4203534 for Taxicab Plate No. 692.

DECISION:

The Tribunal extended taxicab owner's licence No. V02-4203534 for plate No. 692 in the Estate of Bruce Edward Bell for a period of twelve (12) months (up to December 14, 2013).

3. **Andre M. Gray** (*Report No. 5707*)
Holder of Tow Truck Driver's Licence No. D09-3845131

DECISION:

The Tribunal adjourned this matter to March 28, 2013, *peremptory* to Mr. Gray.

4. **Gerald Nelson Jackson** (*Report No. 5990*)

Holder of Building Renovator's Licence No. T85-3723501.

DECISION:

The Tribunal adjourned this matter to February 21, 2013.
(*Mr. Jackson did not attend today's hearing.*)

5. **Philips M. Udofe** (*Report No. 5580*)
Holder of Taxicab Driver's Licence No. D01-3253431.

DECISION:

The Tribunal adjourned this matter to January 31, 2013. The licence remains suspended in the interim and Mr. Udofe is to surrender his licence and photocard to Municipal licensing and Standards, immediately upon returning to Canada.
(*Mr. Udofe did not attend today's hearing.*)

6. **Maurice Francis Williams** (*Report No. 5900*)
Applicant for a Tow Truck Driver's Licence (Application No. B294129).

DECISION:

The Tribunal adjourned this matter to February 21, 2013.
(*Mr. Williams did not attend today's hearing.*)

7. **Mohd Anwar** (*Report No. 5778*)
Applicant for a Driving Instructor's Licence (Application No. B186787).

DECISION:

The Tribunal adjourned this matter to February 14, 2013.

8. **VC's Bar and Grill Ltd.** (*Report No. 5720*)

Applicant for Renewal of Eating Establishment Licence No. B71-3846031.

DECISION:

The Tribunal approved the following joint submission:

VC's Bar and Grill Ltd.'s eating establishment licence will be renewed, effective immediately, subject to the following conditions:

- (1) all outstanding fines In the amount of \$1348.00 must be paid by January 18, 2013, failing which the licence will be suspended until proof of payment of said fines is received by Municipal Licensing and Standards;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on January 17, 2013;
- (3) during the probationary period, VC's Bar and Grill Ltd. must report any charges or convictions under the *Liquor Licence Act* or the *Toronto Municipal Code* to Municipal Licensing and Standards, in writing, within three (3) business days;
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new tickets, charges or convictions, those matters and report No. 5720, and any updating material, may be brought back before the Tribunal for a full hearing;

The Tribunal ordered that VC's Bar and Grill Ltd's eating establishment's licence must be surrendered to Municipal Licensing and Standards by the end of business Friday January 18, 2013 if the fines are not paid.
