**TORONTO LICENSING TRIBUNAL: January 31, 2013****Summary of Decisions****L. Miskin / D. Hall / D. Peacock**

1. **1745944 Ontario Inc.** (*Report No. 5956*)  
o/a Team VRB Motors  
Indar Deo Sharma, President  
Applicant for a Public Garage Licence (Application No. B294042).

**DECISION:**

The Tribunal approved the following joint recommendation:

1745944 Ontario Inc.'s application (No. B294042) for a public garage licence will be granted, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years from January 31, 2013;
- (2) prior to each the next three renewals, Mr. Sharma shall provide to Municipal Licensing and Standards, at his own expense, an updated criminal record check;
- (3) during the probationary period, if Mr. Sharma incurs any charges or convictions under the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5945, and any updating material, shall be brought back before the Tribunal for a full hearing.

2. **Piruz Hassanzadeh-Langrudi** (*Report No. 5836*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-2016454.

**DECISION:**

The Tribunal approved the following joint recommendation:

Piruz Hassanzadeh-Langrudi's taxicab driver's licence No. D01-2016454 will be renewed, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be suspended. Upon proof of payment of all outstanding fines associated with the *Toronto Municipal Code* offences, the suspension shall be lifted on the later of: February 11, 2013 and the date that proof of payment of the fines is filed with the City.
- (2) the licence will be placed on probation for a period of three (3) years commencing January 31, 2013.
- (3) prior to the next three renewals, Mr. Hassanzadeh-Langrudi shall provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Hassanzadeh-Langrudi incurs any new charges or convictions under the *Highway Traffic Act* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing within three (3) business days;
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions under the *Highway Traffic Act* or the *Toronto Municipal Code*, those matters and report No. 5836, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Hassanzadeh-Langrudi to surrender his licence and photo card to Municipal Licensing and Standards immediately.

3. **2248839 Ontario Inc.** (*Report No. 5951*)  
o/a Black Bear Pub  
Ke Fu Ma, President  
Applicant for Renewal of Eating Establishment Licence No. B71-4072422.

**DECISION:**

The Tribunal renewed 2248839 Ontario Inc.'s eating establishment licence No. B71-4072422, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) prior to each of the next two renewals, Mr. Ma must provide to Municipal Licensing and Standards, at his own expense, an updated criminal record check for both the corporation and Mr. Ma, as well as an updated record of any convictions under the *Liquor Licence Act* .
- (3) during the probationary period, if Mr. Ma incurs any new charges or convictions under the *Criminal Code* or *Liquor Licence Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and

- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5951, and any updating material, may be brought back before the Tribunal for a full hearing.

4. **Nazaret Britsian** (*Report No. 5885*)  
Applicant for Renewal of Tow Truck Driver's Licence No. D09-3607450.

**DECISION:**

The Tribunal adjourned this matter to March 21, 2013, *peremptory* to Mr. Britsian.

5. **Estate of Nick Longo** (*Report No. 5979*)  
Stanley A. Fromstein – Estate Trustee During Litigation  
Holder of Taxicab Owner's Licence No. V02-4180398, Plate No. 1269.

**DECISION:**

The Tribunal adjourned this matter to February 28, 2013 and extended taxicab owner's licence No. V02-4180398, plate No. 1269 in the Estate of Nick Longo, in the interim.

6. **Philips M. Udofe** (*Report No. 5580*)  
Holder of Taxicab Driver's Licence No. D01-3253431.

**DECISION:**

The Tribunal adjourned this matter to March 14, 2013, *peremptory* to Mr. Udofe and his licence remains suspended in the interim.

Mr. Udofe is to provide a signed declaration to Municipal Licensing and Standards by Thursday, February 7, 2013 that he is no longer in possession of his taxicab driver's licence or photo card.
