**TORONTO LICENSING TRIBUNAL: February 7, 2013**  
**Summary of Decisions**

1. **Muhammad Arshad** (*Report No. 5890*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-2013252.

**DECISION:**

The Tribunal approved the following pre-hearing agreement:

Muhammad Arshad's taxicab driver's licence No. D01-2013252 will be renewed, effective immediately, subject to the following conditions:

- (1) a five (5) day suspension to Muhammad Arshad's taxicab driver's licence, to commence on February 7, 2013;
- (2) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Arshad must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Arshad incurs any new charges or convictions under the *Highway Traffic Act* or the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5890, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Arshad to surrender his licence and photo card to Municipal Licensing and Standards.

2. **1020386 Ontario Ltd.** (*Report No. 5586*)

Applicant for Renewal of Retail Store Licence No. B50-3843695.  
Holder of Retail Store Licence No. B50-0230516.

**DECISION:**

The Tribunal approved the following pre-hearing agreement:

1020386 Ontario Ltd.'s retail store licence Nos. B50-3843695 and B50-0230516 will be renewed, effective immediately, subject to the following conditions:

- (1) the licences will be placed on probation for a period of two (2) years to commence on February 7, 2013;
- (2) during the probationary period, if 1020386 Ontario Ltd. incurs any new charges or convictions under the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days;
- (3) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5586, and any updating material, shall be brought back before the Tribunal for a full hearing; and
- (4) all outstanding fines must be paid by February 14, 2013, failing which the licence will be suspended until proof of payment is received by Municipal Licensing and Standards.

3. **Antonio Brito Bento** (*Report No. 5879*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3843627.

**DECISION:**

The Tribunal has approved the following pre-hearing agreement:

Antonio Brito Bento's taxicab driver's licence No. D01-3843627 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (2) prior to each of the next three renewals of the licence, Mr. Bento must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Bento incurs any new charges or convictions under the *Highway Traffic Act*, *Toronto Municipal Code* or *Trespass to Property Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has

concerns with any new charges or convictions, those matters and report No. 5879, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. **Cyril A. Udeogba** (*Report No. 5368*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3612627.

**DECISION:**

The Tribunal has approved the following pre-hearing agreement:

Cyril A. Udeogba's taxicab driver's licence No. D01-3612627 will be renewed, effective immediately, subject to the following conditions:

- (1) a three (3) day suspension to Cyril A. Udeogba's taxicab driver's licence No. D01-3612627, to commence on February 11, 2013;
- (2) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Udeogba must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Udeogba incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5368, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Udeogba to surrender his licence and photo card to Municipal Licensing and Standards on Monday, February 11, 2013.

5. **Shanthiragaanth Sathasivam** (*Report No. 5688*)  
Applicant for Renewal of Limousine Owner's Licence No. V04-3842006.

**DECISION:**

The Tribunal has approved the following pre-hearing agreement:

Shanthiragaanth Sathasivam's limousine owner's licence No. V04-3842006 will be renewed, effective immediately, subject to the following conditions:

- (1) a three (3) day suspension to Shanthiragaanth Sathasivam's limousine owner's licence, to commence on February 8, 2013;
- (2) the licence will be placed on probation for a period of three (3) years to commence on February 8, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Sathasivam must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Sathasivam incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5688 and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Sathasivam to surrender his licence and plates to Municipal Licensing and Standards Friday, February 8, 2013.

**6. Onel Reyes Gainza** (*Report No. 5975*)  
Applicant for a Taxicab Driver's Licence (Application No. B185095).

**DECISION:**

The Tribunal approved the following pre-hearing agreement:

Onel Reyes Gainza's application for a taxicab driver's licence will be granted, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (2) prior to each of the next three renewals of the licence, Mr. Reyes Gainza must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving and criminal records;
- (3) during the probationary period, if Mr. Reyes Gainza incurs any new charges or convictions under the *Highway Traffic Act*, *Criminal Code* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has

concerns with any new charges or convictions, those matters and report No. 5975, and any updating material, shall be brought back before the Tribunal for a full hearing.

**7. Dart Transportation Ltd. (Report No. 5834)**

Applicant for Renewal of Taxicab Owner Licence Nos. V02-0005591, V02-0005633, V02-0006532, V02-0005641, V02-0005609, V02-0005583 and V02-0010336.

Holder of Taxicab Owner Licence Nos. V02-0049849, V02-0049848, V02-0049846, V02-0049845, V02-0049844, V02-0010344, V02-0006839, V02-0005658, V02-0005617, V02-0006540 and V02-0005575.

**DECISION:**

The Tribunal has approved the following pre-hearing agreement:

Dart Transportation Ltd.'s taxicab owner's licenses will be renewed, effective immediately, subject to the following conditions:

- (1) the licences will be placed on probation for a period of two (2) years to commence on February 7, 2013;
- (2) during the probationary period, if Dart Transportation Ltd. incurs any new charges or convictions under the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (3) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5834, and any updating material, shall be brought back before the Tribunal for a full hearing.

**8. Ephreme Seyefu Zegeye (Report No. 5766)**

Applicant for Renewal of Taxicab Driver's Licence No. D01-3370216.

**DECISION:**

The Tribunal has approved the following joint recommendation:

Ephreme Seyefu Zegeye's taxicab driver's license No. D01-3370216 will be renewed, effective immediately, subject to the following conditions:

- (1) all outstanding fines must be paid by March 7, 2013, failing which the licence will be suspended until proof of payment is received by Municipal Licensing and Standards;
- (2) the licence will be placed on probation for a period of three (3) years from September 28, 2012;

- (3) prior to each of the next three renewals, Mr. Zegeye must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Zegeye incurs any new charges or convictions under the *Highway Traffic Act* and/or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days;
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5766, and any updating material, shall be brought back before the Tribunal for a full hearing; and
- (6) Mr. Zegeye fails to pay all outstanding *Highway Traffic Act* and *Toronto Municipal Code* offence fines by March 7, 2013, Mr. Zegeye's taxicab driver's licence shall be cancelled.

**9. Abukar Ali Sabrie** (*Report No. 5539*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3590322.

**DECISION:**

The Tribunal has approved the following joint recommendation:

Abukar Ali Sabrie's taxicab driver's licence No. D01-3590322 will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (2) prior to each of the next three renewals of the licence, Mr. Sabrie must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Sabrie incurs any new charges or convictions under the *Highway Traffic Act* or *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5539, and any updating material, shall be brought back before the Tribunal for a full hearing.

- 10. Mohammad Rizwan Raja** (*Report No. 5628*)  
Applicant for a Taxicab Driver's Licence (Application No. B177967).

**DECISION:**

The Tribunal has approved the following joint recommendation:

Mohammad Rizwan Raja's application (No. B177967) for a taxicab driver's licence will be granted, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on February 7, 2013;
- (2) prior to each of the next three renewals of the licence, Mr. Raja must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving and criminal records;
- (3) during the probationary period, if Mr. Raja incurs any new charges or convictions under the *Highway Traffic Act*, *Liquor Licence Act* or *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5628, and any updating material, shall be brought back before the Tribunal for a full hearing.

- 11. Tanja Korac** (*Report No. 4784*)  
Applicant for Renewal of Refreshment Vehicle Driver's Licence No. D13-3594033.

**DECISION:**

The Tribunal deemed this matter abandoned and revoked Tanja Korac's refreshment vehicle driver's licence No. D13-3594033, effective immediately.  
(*Ms. Korac did not attend today's hearing.*)
