
TORONTO LICENSING TRIBUNAL: April 4, 2013
Summary of Decisions

1. **Yunusa Akinyemi Eludoyin** (*Report No. 5904*)
Applicant for Renewal of Taxicab Owner's Licence No. V02-3364854.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Yunusa Akinyemi Eludoyin's licence will be renewed, effective immediately, subject to the following conditions:

- (1) the licence will be placed on probation for a period of three (3) years to commence on April 4, 2013;
- (2) the licence will be suspended for seven (7) days to commence on April 4, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Eludoyin must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Eludoyin incurs any new charges or convictions under the *Toronto Municipal Code* or *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5904, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered an amendment to the Pre-hearing Settlement: The suspension of the licence will be lifted on the later of: April 11, 2013 and the date proof of payment of the by-law fines is filed with the City.

Mr. Eludoyin is to surrender his plate to Municipal Licensing and Standards on April 4, 2013.

2. **Ahmed Nawaz Khan** (*Report No. 5908*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3948809.

DECISION:

The Tribunal adjourned this matter to April 25, 2013, *peremptory* to Mr. Khan.
(*Mr. Khan failed to attend today's hearing.*)

3. **Maurice Francis Williams** (*Report No. 5900*)
Applicant for a Tow Truck Driver's Licence (Application No. B294129).

DECISION:

The Tribunal adjourned this matter to May 2, 2013, *peremptory* to Mr. Williams.
