
TORONTO LICENSING TRIBUNAL: April 11, 2013
Summary of Decisions

1. **Buruk Tedla** (*Report No. 5992*)
Holder of Taxicab Driver's Licence No. D01-3610622.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Buruk Tedla's licence will have the following conditions imposed, effective immediately:

- (1) Mr. Tedla must provide to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) the licence will be suspended for a period of five (5) days;
- (3) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on April 11, 2013;
- (4) prior to each of the next three renewals of the licence, Mr. Tedla must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (5) during the probationary period, if Mr. Tedla incurs any new charges or convictions under the *Toronto Municipal Code* or *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (6) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5992, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Tedla to surrender his licence and photo card to Municipal Licensing and Standards, effective immediately.

2. **Target Park Inc.** (*Report No. 5723*)

And

Applicant for Public Garage (Parking Lot) Licences (Application Nos. B179091, B179659, B184927, B185464, B291307, B291309, B185462, B184926 and B304606).

DECISION:

The Tribunal approved the following pre-hearing agreement:

Target Park Inc.'s public garage (parking lot) licences will be renewed and application (Nos. B179091, B179659, B184927, B185464, B291307, B291309, B185462, B184926 and B304606) for public garage licences will be granted, effective immediately, subject to the following conditions:

- (1) Target Park Inc. must provide to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) immediately upon the licences being renewed and Application Nos. B179091, B179659, B184927, B185464, B291307, B291309, B185462, B184926 and B304606 being granted, the licences will be placed on probation for a period of two (2) years to commence on April 11, 2013;
- (3) during the probationary period, if Target Park Inc. incurs any new charges or convictions under the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5723, and any updating material, shall be brought back before the Tribunal for a full hearing.

3. **Abdulla Nassir Ali** (*Report No. 5925*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3591132.

DECISION:

The Tribunal approved the following pre-hearing agreement:

Abdulla Nassir Ali's licence will be renewed, effective immediately, subject to the following conditions:

- (1) Mr. Ali must provide to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on April 11, 2013;

- (3) prior to each of the next 3 renewals of the licence, Mr. Ali must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Ali incurs any new charges or convictions under the *Toronto Municipal Code* or *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5925, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. **Michael C. Sampson** (*Report No. 5642*)
Applicant for Renewal of Taxicab Owner's Licence No. V02-3101118.

DECISION:

The Tribunal adjourned this matter to May 30, 2013.
(*Mr. Sampson did not attend today's hearing*).

5. **Rezaul Talukder** (*Report No. 5667*)
Applicant for Renewal of Pedicab Driver's Licence No. D18-3478127.

DECISION:

The Tribunal deemed this matter as abandoned.
(*Mr. Talukder did not attend today's hearing*).

6. **Ali Abbas** (*Report No. 5993*)
Holder of Taxicab Driver's Licence No. D01-4063920.

DECISION:

The Tribunal adjourned this matter, on consent, to May 23, 2013, *peremptory* to Mr. Abbas.

7. **Morgan Otuo Acheampong** (*Report No. 5996*)
Holder of Taxicab Driver's Licence No. D01-3121821.

DECISION:

The Tribunal adjourned this matter to July 18, 2013 and suspended the licence in the interim. Mr. Acheampong is to surrender his licence to Municipal Licensing and Standards, effective immediately.

8. **Piruz Hassanzadeh-Langrudi** (*Report No. 6012*)
Holder of Taxicab Driver's Licence No. D01-2016454.

DECISION:

The Tribunal adjourned this matter to May 30, 2013, *peremptory* to Mr. Hassanzadeh-Langrudi.

9. **Mubshar Mahmood** (*Report No. 6025*)
Holder of Taxicab Driver's Licence No. D01-3354998.

DECISION:

With Tribunal Member Ken Chan dissenting, the Tribunal adjourned this matter to November 28, 2013 with no interim suspension.
