**TORONTO LICENSING TRIBUNAL: April 18, 2013**  
**Summary of Decisions**

1. **Raphael Kumar Das** (*Report No. 6028*)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3126854.

**DECISION:**

The Tribunal adjourned this matter to May 16, 2013, *peremptory* to Mr. Das and advised him to consider legal representation.

2. **Sandra A. Waterhouse** (*Report No. 6027*)  
Holder of Taxicab Owner's Licence No. V02-3371624 for plate No. 1682.

**DECISION:**

The Tribunal imposed the following conditions on Sandra A. Waterhouse's taxicab owner's licence:

- (1) the licence will be suspended for a period of ten (10) days, effective April 19, 2013;
- (2) the licence will be placed on probation for a period of one (1) year to commence on April 18, 2013;
- (3) during the probationary period, if Municipal Licensing and Standards has concerns with any mechanical defects resulting in a plate removal, the matter and report No. 6027, and any updating material, shall be brought back before the Tribunal.
- (4) if there are no further plate removals during the probationary period, the matter will be considered finalized.

The Tribunal ordered John Amar to surrender Sandra A. Waterhouse's plate and licence at 9:00 a.m. on Friday, April 19, 2013.

3. **Frank Fortese** (*Report No. 5949*)  
Applicant for Renewal of Tow Truck Driver's Licence No. D09-3957296.

**DECISION:**

The Tribunal approved the following pre-hearing agreement:

Frank Fortese's tow truck driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) Mr. Fortese provides to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on April 18, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Fortese must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Fortese incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5949, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. **Eris Prifti** (*Report No. 6045*)  
o/a Euro Line Auto Repair  
Applicant for a Public Garage Licence (Application No. B203529).

**DECISION:**

The Tribunal approved the following pre-hearing agreement:

Eris Prifti's application (No. B203529) for a public garage licence will be granted, effective immediately, subject to the following conditions:

- (1) Mr. Prifti provides to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on April 18, 2013;

- (3) prior to each of the next three renewals of the licence, Mr. Prifti must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (4) during the probationary period, if Mr. Prifti incurs any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6045, and any updating material, shall be brought back before the Tribunal for a full hearing.

5. **Mohammad Ali Shahjahan** (*Report No. 5937*)  
Holder of Taxicab Driver's Licence No. D01-3844033.

**DECISION:**

The Tribunal revoked Mohammad Ali Shahjahan's taxicab driver's licence No. D01-3844033, effective immediately.

6. **Estate of Myer Klein** (*Report No. 6033*)  
Marsha Klein, Trustee  
Holder of Taxicab Owner's Licence No. V02-0040358, Taxicab Plate No. 2180.

**DECISION:**

The Tribunal adjourned this matter to April 25, 2013.

7. **Estate of Frank Lewicki** (*Report No. 6047*)  
Shelley Lewicki, Executrix  
Holder of Taxicab Owner's Licence Nos. V02-4203651 and V02-4203653, Plate Nos. 1393 and 1994.

**DECISION:**

The Tribunal extended taxicab owner's licence Nos. V02-4203651 and V02-4203653, plate Nos. 1393 and 1994 in the Estate of Frank Lewicki for a period of six (6) months.

8. **Nazir Rassy** (*Report No. 6019*)  
Applicant for a Tow Truck Driver's Licence (Application No. B304722).

**DECISION:**

The Tribunal deemed this matter as abandoned without prejudice to the applicant to re-apply.

*(Mr. Rassy failed to attend today's hearing).*

9. **Krista Kathleen Harrison** (*Report No. 6010*)  
Applicant for a Tow Truck Driver's Licence (Application No. B304675).

**DECISION:**

The Tribunal deemed this matter as abandoned without prejudice to the applicant to re-apply.

*(Ms. Harrison failed to attend today's hearing).*
