Applicant for Renewal of Taxicab Broker's Licence No. B03-3947698

DECISION:

The Tribunal approved the following proposed resolution:

2195482 Ontario Ltd.'s taxicab broker's licence will be renewed, effective immediately, subject to the following conditions:

- (1) 2195482 Ontario Ltd. must provide to Municipal Licensing and Standards proof of payment of any outstanding fines;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on June 13, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Abou-Sawan must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (4) during the probationary period, if 2195482 Ontario Ltd. or Mr. Abou-Sawan incurs any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5911, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal approved the following proposed resolution:

Peter Charles Badoo's Ambassador taxicab owner's licence will be renewed, effective immediately, subject to the following conditions:

- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on June 13, 2013;
- (3) prior to each of the next three renewals of the licence, Mr. Badoo must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Badoo incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5961, and any updating material, shall be brought back before the Tribunal for a full hearing.
