## TORONTO LICENSING TRIBUNAL: July 25, 2013

### Summary of Decisions

- 1. Amada Yolanda Camacho** (Report No. 6090)  
Applicant for a Body Rubber's Licence (Application No. B305112)

**DECISION:**

The Tribunal deemed Amada Yolanda Camacho's application for a body rubber's licence as abandoned, without prejudice to her re-applying at a later date.

*(Ms. Camacho failed to attend today's hearing).*

- 2. Cassandra Kathleen Howell** (Report No. 6070)  
Applicant for a Body Rubber's Licence (Application No. B308460)

**DECISION:**

The Tribunal granted Cassandra Kathleen Howell a body rubber's licence subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on July 25, 2013;
- (2) during the probationary period, if Ms. Howell incurs any new charges or convictions under the *Criminal Code*, she must notify Municipal Licensing and Standards, in writing, within five (5) business days which can be done in the following ways:

**DECISION:**

The Tribunal granted Tarza Construction Services Corp. a building renovator's licence, subject to the following conditions:

- (2) prior to each of the next two renewals of the licence, Mr. Zarate must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (3) during the probationary period, if Camilo Javier Zarate incurs any new charges or convictions under the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days which can be done in the following ways; and

**DECISION:**

The Tribunal approved the following proposed resolution:

Wei Tan's holistic centre licence and Alice Spa Inc.'s holistic centre licence (collectively referred to as the "Holistic Centre Licences") will be renewed, effective immediately, subject to the following conditions to be placed on both the holistic centre licences and Wei Tan's holistic practitioner licence:

- (1) the licences shall be immediately suspended for a period of five (5) days, commencing on July 25, 2013 and Ms. Tan must surrender her holistic practitioner photo card on that date;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on July 25, 2013;
- (3) during the probationary period, if Ms. Tan or Alice Spa Inc. incurs any new charges or convictions under the *Toronto Municipal Code*, they

must notify Municipal Licensing and Standards, in writing, within five (5) business days which can be done in the following ways; and
