**TORONTO LICENSING TRIBUNAL: August 8, 2013**  
**Summary of Decisions**

- 1. Anita Singh** (Report No. 6039)  
o/a Anita's Driving Academy  
Applicant for Renewal of Driving School Operator's Licence No. B12-4178339

**DECISION:**

The Tribunal approved the following proposed resolution:

Anita Singh's driving school operator's licence will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be suspended for a period of four days effective August 8, 2013. Ms. Singh must surrender her driving school operator's licence and photo card on that date;
- (2) Ms. Singh must provide to Municipal Licensing and Standards proof of payment of any outstanding by-law fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed;
- (3) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on August 8, 2013;
- (4) during the probationary period, if Ms. Singh incurs any new charges or convictions under the *Toronto Municipal Code*, she must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
  - in person at 850 Coxwell Avenue, Toronto, ON M4C 5R1
  - via regular mail to: 850 Coxwell Avenue, Toronto, ON M4C 5R1
  - via e-mail to [mlsconditionreporting@toronto.ca](mailto:mlsconditionreporting@toronto.ca); or
  - via fax at 416-392-3102; and
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6039, and any updating material, shall be brought back before the Tribunal for a full hearing.

***With the consent of all parties, the Tribunal ordered two amendments to the proposed resolution as follows:***

- (i) Remove the words photo card from Condition No. 1***
- (ii) Remove Condition No. 2***

**2. Bikramjit Singh Dhaliwal** (Report No. 5096)  
Applicant for a Tow Truck Driver's Licence (Application No. A845753)

**DECISION:**

The Tribunal denied Bikramjit Singh Dhaliwal's application for a tow truck driver's licence.

*(Mr. Dhaliwal did not attend today's hearing)*

**3. Worku Bezuneh** (Report No. 6014)  
Applicant for Renewal of Taxicab Driver's Licence No. D01-3962101

**DECISION:**

The Tribunal approved the following joint recommendation:

Worku Bezuneh's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be suspended for a period of two days effective August 8, 2013. Mr. Bezuneh must surrender his taxicab driver's licence and photo card today to Municipal Licensing and Standards;
- (2) Mr. Bezuneh must provide to Municipal Licensing and Standards proof of payment of all outstanding fines as set out at Page 8 of Report No. 6014, excluding Line Item 4. This proof must be filed prior to the end of the suspension period, failing which the licence will remain suspended until proof of payment of all outstanding fines is filed.
- (3) immediately upon being renewed, the licence will be placed on probation for a period of two years to commence on August 8, 2013;
- (4) during the probationary period, if Mr. Bezuneh incurs any new charges or convictions under *the Toronto Municipal Code* or *the Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
