
TORONTO LICENSING TRIBUNAL: January 9, 2014

- 1. Ahmed Nawaz Khan** (Report No. 5908)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3948809

DECISION:

The Tribunal denied Ahmed Nawaz Khan's application for renewal of taxicab driver's licence No. D01-3948809.

(Mr. Khan failed to attend today's hearing).

- 2. Tehseen Perweez Mir** (Report No. 6023)
Holder of Taxicab Driver's Licence No. D01-4075524

DECISION:

Tehseen Perweez Mir's taxicab driver's licence No. D01-4075524 will have the following conditions imposed upon it, effective immediately:

- (1) the licence shall be immediately suspended for a period of forty-five (45) days to commence on January 9, 2014 and the licensee must surrender his taxicab driver's licence and photo card on January 9, 2014;
- (2) the licence will be placed on probation for a period of three (3) years to commence on January 9, 2014;
- (3) prior to each of the next three renewals of the licence, Mr. Mir must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his criminal record and driving record;

DECISION:

The Tribunal approved the following joint settlement:
