
TORONTO LICENSING TRIBUNAL: January 30, 2014

1. Harjap Singh Dehar (Report No. 6105)

Holder of Taxicab Owner's Licence No. V02-3604145 for Taxicab Plate No. 3210

DECISION:

The Tribunal adjourned this matter to April 3, 2014 and ordered Harjap Singh Dehar to surrender his taxicab driver's licence, his taxicab owner's licence No. V02-3604145 and plate No. 3210, effective immediately.

Upon the availability of Robert Stewart (Mr. Dehar's representative), City Legal and the Tribunal office, this matter may be brought back before the Tribunal at an earlier date.

2. Yadwinder Singh Pannu (Report No. 6106)

Holder of Taxicab Owner's Licence No. V02-3484254 for Taxicab Plate No. 410
Agent for Taxicab Plate Nos. 623, 1403 and 3210

DECISION:

The Tribunal adjourned this matter to April 3, 2014 and ordered Yadwinder Singh Pannu to surrender his taxicab driver's licence, his taxicab owner's licence No. V02-3484254 and plate No. 410, effective immediately. Mr. Pannu is suspended from acting as agent for plate Nos. 623, 1403 and 3210.

Upon the availability of Robert Stewart (Mr. Pannu's representative), City Legal and the Tribunal office, this matter may be brought back before the Tribunal at an earlier date.

3. Tewodros Mekonene (Report No. 6113)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3719244

DECISION:

January 30, 2014

The Tribunal approved the following jointly proposed resolution:

Tewodros Mekonene's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) the licence shall be immediately suspended for a period of seven (7) days to commence on January 30, 2014, and the licensee must surrender his taxicab driver's licence and photo card on January 30, 2014;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on January 30, 2014;
- (3) prior to each of the next three renewals of the licence, Mr. Mekonene must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (4) commencing every 6 months from January 30, 2014, Mr. Mekonene must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (5) during the probationary period, if Mr. Mekonene incurs any new charges or convictions under the *Toronto Municipal Code*, the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (6) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No.6113, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Tewodros Mekonene surrender his licence and photo card to Municipal Licensing and Standards immediately.

4. Jamie Lee Howell (Report No. 6155)
Applicant for a Tow Truck Driver's Licence (Application No. B315350)
