- 1. Zeshan Malik** (Report No. 6024)
Holder of Taxicab Driver's Licence No. D01-3839812

DECISION:

The Tribunal revoked Zeshan Malik's taxicab driver's licence No. D01-3839812.

(Mr. Malik failed to attend today's hearing).

- 2. Alireza Bandzar** (Report No. 6159)
Applicant for a Taxicab Driver's Licence (Application No. B312942)

DECISION:

The Tribunal denied Alireza Bandzar's application (No. B312942) for a taxicab driver's licence.

- 3. Inderpal Singh** (Report No. 6161)
Applicant for a Limousine Driver's Licence (Application No. B315606)

DECISION:

The Tribunal approved the following joint settlement:

Inderpal Singh's licence will be granted, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on February 6, 2014;
- (2) prior to each of the next three renewals of the licence, Mr. Singh must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of driving record and criminal record;

(3) during the probationary period, if Mr. Singh incurs any new charges or convictions under the *Toronto Municipal Code*, the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via email to mlsconditionreporting@toronto.ca; or
- via fax at 416-392-3102

(4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6161, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. 1808864 Ontario Ltd. (Report No. 6157)

Applicant for an Eating Establishment Licence (Application No. B315830)

DECISION:

1808864 Ontario Ltd.'s licence will be issued, effective immediately, subject to the following conditions:

(1) the licence is immediately suspended until proof is provided to Municipal Licensing and Standards that the fines outstanding of Mr. Tavares and Friend's Bakery, Deli & Snack Bar have been resolved to the satisfaction of Municipal Licensing and Standards;

(2) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on February 6, 2014;

(3) during the probationary period, if 1808864 Ontario Ltd. or David Alberto Tavares incur any new charges or convictions under the *Fire Marshal's Act*, the *Liquor Licence Act*, the *Health Protection and Promotions Act* or the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via email to mlsconditionreporting@toronto.ca; or
- via fax at 416-392-3102

- (4) no alcohol or liquor is to be found on the premises and the business will be prohibited from selling or serving liquor;
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6157, and any updating material, shall be brought back before the Tribunal for a full hearing.
