BY-LAW -2017

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Fort Rouille Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Fort Rouille Street	East	Springhurst Avenue and a point 30.5 metres south	Anytime
Fort Rouille Street	West	Springhurst Avenue and a point 36.5 metres south	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Fort Rouille Street	West	The south end of Fort Rouille Street and a point 47.5 metres south of Springhurst Avenue	Anytime

Fort Rouille Street	West	A point 38.5 metres south of Springhurst Avenue and a point 9 metres further south	8:00 a.m. to 6:00 pm.	1 hour

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:
