**Bill 152**

**BY-LAW -2018**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting designated delivery vehicle parking zones on Adelaide Street West and Scott Street.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By inserting in Schedule IX (Delivery Vehicle Parking Zones) in § 950-1308, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Adelaide Street West	North	Between a point 17.5 metres east of York Street and a point 27 metres further east	10:00 a.m. to 3:00 p.m., Mon. to Fri., except public holidays	20 mins.
Scott Street	East	Between a point 14 metres north of The Esplanade and a point 22 metres further north	Anytime	20 mins.

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Adelaide Street West	North	Simcoe Street and Yonge Street	Anytime
Scott Street	East	The Esplanade and Scott Lane	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Adelaide Street West	North	Simcoe Street and a point 17.5 metres east of York Street	Anytime
Adelaide Street West	North	A point 17.5 metres east of York Street and a point 27 metres further east	7:00 p.m. of one day to 7:00 a.m. of the next following day, Mon. to Fri.; Anytime Sat. Sun. and public holidays
Adelaide Street West	North	A point 44.5 metres east of York Street and Yonge Street	Anytime
Scott Street	East	A point 36 metres north of The Esplanade and Scott Lane	Anytime

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Adelaide Street West	North	A point 17.5 metres east of York Street and a point 27 metres further east	10:00 a.m. to 3:00 p.m., Mon. to Fri., except public holidays	20 mins. (delivery vehicle parking zone)
Scott Street	East	A point 14 metres north of The Esplanade and a point 22 metres further north	Anytime	20 mins. (delivery vehicle parking zone)

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Adelaide Street West	North	University Avenue and a point 84 metres west of Sheppard Street	11:30 a.m. to 1:30 p.m. Mon. to Fri., except public holidays

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Adelaide Street West	North	University Avenue and a point 17.5 metres east of York Street	11:30 a.m. to 1:30 p.m. Mon. to Fri., except public holidays
Adelaide Street West	North	A point 44.5 metres east of York Street and a point 84 metres west of Sheppard Street	11:30 a.m. to 1:30 p.m. Mon. to Fri., except public holidays
