BY-LAW -2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Freshmeadow Drive.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |

| Freshmeadow Drive | South | A point 164.7 metres east of Don Mills Road and a point 369.1 metres east of Don Mills Road | 9:00 a.m. to 3:00 p.m. and 6:00 p.m. of one day to 7:00 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun. |

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:
