BY-LAW -2020

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Lake Shore Boulevard West.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Lake Shore Boulevard West	North	A point 74 metres west of Thirty Ninth Street and the most easterly outbound access from Brown's Line	6:00 p.m. of one day to 8:00 a.m. of the next following day
Lake Shore Boulevard West	North	Thirty Ninth Street and a point 26 metres west of the most westerly inbound access to Brown's Line	6:00 p.m. of one day to 8:00 a.m. of the next following day

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Lake Shore Boulevard West	North	A point 74 metres west of Thirty Ninth Street and the most easterly outbound access from Brown's Line	8:00 p.m. of one day to 5:00 a.m. of the next following day
Lake Shore Boulevard West	North	Thirty Ninth Street and a point 26 metres west of the most westerly inbound access to Brown's Line	8:00 p.m. of one day to 5:00 a.m. of the next following day

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Lake Shore Boulevard West	North	A point 26 metres west of the most westerly inbound access to Brown's Line and a point opposite Thirty Ninth Street	8:00 a.m. to 6:00 p.m.	1 hour
Lake Shore Boulevard West	North	A point 74 metres west of Thirty Ninth Street and the most easterly outbound access from Brown's Line	8:00 a.m. to 6:00 p.m.	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Lake Shore Boulevard West	North	A point 26 metres west of the most westerly inbound access to Brown's Line and a point opposite Thirty Ninth Street	5:00 a.m. to 8:00 p.m.	1 hour
Lake Shore Boulevard West	North	A point 74 metres west of Thirty Ninth Street and the most easterly outbound access from Brown's Line	5:00 a.m. to 8:00 p.m.	1 hour
