### **BY-LAW -2020**

#### **To amend:**

**City of Toronto By-law 322-2020, as amended by City of Toronto By-law 342-2020, to retain physical distancing regulations with respect to Parks;**

**City of Toronto By-law 323-2020, as amended by City of Toronto By-law 342-2020, to retain physical distancing regulations with respect to Public Squares;**

**City of Toronto By-law 541-2020, as amended by City of Toronto By-law 664-2020, to retain requirements for the wearing of masks or other face coverings; and**

**Toronto Municipal Code Chapter 354, Apartment Buildings, § 354-3.11.A to retain requirements reducing the risk from COVID-19.**

The Council of the City of Toronto enacts:

1. City of Toronto By-law 322-2020, as amended by City of Toronto By-law 342-2020, is further amended by deleting section 3 and replacing it with the following:
  3. The above amendments, enacted and passed as City of Toronto By-law 322-2020 under Emergency Order No. 1 issued by Mayor John Tory, both dated April 2, 2020 and as extended by City of Toronto By-law 342-2020, are further extended by City Council at its September 30 and October 1, 2020 meeting and remain in effect until 12:01 a.m. on the first day after the first City Council meeting in 2021, unless extended by City Council.
2. City of Toronto By-law 323-2020, as amended by City of Toronto By-law 342-2020, is further amended by deleting section 2 and replacing it with the following:
  2. The above amendment, enacted and passed as City of Toronto By-law 323-2020 under Emergency Order No. 2 issued by Mayor John Tory, dated April 3, 2020 and as extended by City of Toronto By-law 342-2020, is further extended by City Council at its September 30 and October 1, 2020 meeting and remains in effect until 12:01 a.m. on the first day after the first City Council meeting in 2021, unless extended by City Council.
3. City of Toronto By-law 541-2020, as amended by City of Toronto By-law 664-2020, is further amended by deleting section 9 and replacing it with the following:
  9. Each provision of this By-law shall come into force 7 days after the date of its enactment under this By-law or a subsequent amending By-law and is deemed to

be no longer in effect and revoked at 12:01 a.m. on the first day after the first City Council meeting in 2021, unless extended by City Council.

4. City of Toronto By-law 664-2020 is amended by deleting section 8 and replacing it with the following:
  8. This By-law shall come into force 7 days after the date of enactment of this By-law and is deemed to be no longer in effect and revoked at 12:01 a.m. on the first day after the first City Council meeting in 2021, unless extended by City Council.
5. § 354-3.11.A City of Toronto Municipal Code Chapter 354, Apartment Buildings, is amended by deleting the phrase "until October, 2020" and replacing it with the phrase "until the first day after the first City Council meeting in 2021, unless extended by City Council".
