BY-LAW -2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Duplex Avenue, Harlandale Avenue, Milepost Place, Tolman Street in Wards 15 and 18.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Number of Spaces)	(From Column 5 Car-Share Organization/Company)
Duplex Avenue	East	A point 9 metres north of Finch Avenue West and 11 metres further north	2	AutoShare
Harlandale Avenue	North	A point 14 metres east of Beecroft Road	2	AutoShare
Milepost Place	South	A point 9 metres west of Thorncliffe Park Drive and a point 11 metres further west	2	Car2Go
Tolman Street	North	A point 26 metres west of Yonge Street and a point 11 metres further west	2	AutoShare

- B. By inserting in Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Number of Spaces)	(In Column 5 Car-Share Organization/Com pany)
Harlandale Avenue	North	A point 14 metres east of Beecroft Road and a point 11 metres further east	Up to 2	Enterprise CarShare
Tolman Street	North	A point 26 metres west of Yonge Street and a point 11 metres further west	Up to 2	Enterprise CarShare

- C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Duplex Avenue	East	A point 9 metres north of Finch Avenue West and a point 11 metres further north	Anytime (car-share vehicles excepted)
Milepost Place	South	A point 9 metres west of Thorncliffe Park Drive and point 22 metres further west	Anytime (car-share vehicles excepted)

- D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Duplex Avenue	East	A point 9 metres north of Finch Avenue West and a point 11 metres further north	Anytime
Milepost Place	South	A point 20 metres west of Thorncliffe Park Drive and point 11 metres further west	Anytime (car-share vehicles excepted)
Milepost Place	South	A point 9 metres west of Thorncliffe Park Drive and a point 11 metres further west	Anytime
