BY-LAW -2022

To amend City of Toronto Chapter 19, Business Improvement Areas; to dissolve the Board of Management of the Bloor Street Business Improvement Area; to repeal By-law 519-2006, being a by-law to designate an area along Bloor Street between St. Paul's Square and just west of Avenue Road, as an improvement area; and to repeal By-law 69-2007, being a by-law to amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Bloor Street Business Improvement Area and to establish a Board of Management for the Bloor Street Business Improvement Area.

Whereas Municipal Code Chapter 19, Business Improvement Areas designates various areas of the City as Business Improvement Areas, including the Bloor Street Business Improvement Area; and

Whereas sections 7, 8 and 145 of the City of Toronto Act, 2006 authorize the City to dissolve a local board; and

Whereas business improvement area boards are local boards of the City of Toronto; and

Whereas City Council has authorized the dissolution of the Board of Management of the Bloor Street Business Improvement Area, and the repeal of the board of management and designation by-laws.

The Council of the City of Toronto enacts:

- 1. By-law 519-2006, being a by-law "To designate an area along Bloor Street between St. Paul's Square and just west of Avenue Road, as an improvement area", is repealed.
- 2. The Board of Management of the Bloor Street Business Improvement Area is dissolved.
- 3. Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) By deleting "Bloor Street Business Improvement Area" from the list in § 19-1.2.
 - (2) By deleting the following from the table in Schedule A Boards of Management:

- (3) By deleting "Bloor Street 3 maps" from Schedule A, Business Improvement Area Maps.
- (4) By deleting the "Bloor Street Business Improvement Area Maps" from Schedule A, Business Improvement Area Maps.
- 4. By-law 69-2007, being a by-law "To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Bloor Street Business Improvement Area and to establish a Board of Management for the Bloor Street Business Improvement Area", is repealed.
