Bill 295

BY-LAW -2022

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Palmerston Avenue, Palmerston Square and Tecumseth Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:
