### Bill 420

### BY-LAW -2022

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Spadina Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands for Taxi Cabs) in § 950-1304, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Number of Taxicabs)	(From Column 5 Times and/or Days)
Spadina Avenue	West	Between a point 70 metres north of College Street and a point 12 metres further north	2	Anytime except 7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri.

B. By inserting in Schedule V (Stands for Taxi Cabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Spadina Avenue	West	A point 58 metres north of College Street and a point 12 metres further north	2	Anytime except 7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri.

C. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Spadina Avenue	West	Between a point 70 metres north of College Street and a point 12 metres further north	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri., for maximum period of 15 mins.

D. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Spadina Avenue	West	A point 58 metres north of College Street and a point 12 metres further north	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri., for maximum period of 15 mins.

E. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Spadina Avenue	West	A point 60 metres south of College Street and a point 70 metres north of College Street	Anytime

F. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Spadina Avenue	West	A point 60 metres south of College Street and a point 58 metres north of College Street	Anytime

G. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Spadina Avenue	West	A point 70 metres north of College Street and a point 12 metres further north	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri.	15 mins.

H. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Spadina Avenue	West	A point 58 metres north of College Street and a point 12 metres further north	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 5:30 p.m., Mon. to Fri.	15 mins.
