## CITY OF TORONTO

**Bill 449**

**BY-LAW -2022**

### **To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, respecting Knox Avenue.**

Whereas City Council on April 6 and 7, 2022, adopted as amended Item IE28.7 wherein Attachment 5 (March 15, 2022) from the General Manager, Transportation Services authorized an entry for Knox Avenue to be inserted into Schedule E, Cycle Tracks, of City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks;

Whereas City Council on April 7, 2022 enacted By-law 274-2022, being a by-law " To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, respecting Knox Avenue." and incorrectly included the between entry as "The south end and Eastern Avenue" instead of "The south end of Knox Avenue and Eastern Avenue" in the 2nd column of the entry for Knox Avenue;

Whereas, pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, is amended as follows:
  - A. By deleting from Schedule E (Cycle Tracks) the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Lanes)	(From Column 4 Times or Days)
Knox Avenue	The south end and Eastern Avenue	Westerly Northbound lane adjacent to the westerly southbound cycle track	Anytime

B. By inserting in Schedule E (Cycle Tracks) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Knox Avenue	The south end of Knox Avenue and Eastern Avenue	Westerly Northbound lane adjacent to the westerly southbound cycle track	Anytime
