## **CITY OF TORONTO**

### **BY-LAW No. 156-1998**

#### **To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting King Street West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule VIII (Prohibited turns) in §400-61, the following in alphabetical order by street name:
