## **CITY OF TORONTO**

### **BY-LAW No. 190-1998**

#### **To amend further Metropolitan By-law No. 107-86 respecting parking meters on former Metropolitan Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** Schedule 1 of Metropolitan By-law No. 107-86, being a By-law “Respecting parking meters on former Metropolitan Roads”, as amended, is further amended by striking out the words and figures:
