## BY-LAW No. 240-1998

# To exempt 1090 Shaw Street from the provisions of subsection 50(5) of the Planning Act.

WHEREAS Subsection 50(7) of the Planning Act, R.S.O. 1990, c.P.13, as amended, states that the council of a local municipality may by by-law provide that Subsection 50(5) of the Planning Act, R.S.O. 1990, c.P.13, as amended, does not apply to land that is within a registered plan of subdivision or part or parts thereof; and

WHEREAS Council of the former City of Toronto, at its meeting held on the 12th day of May, 1997, adopted, as amended, Clause 10 of Land Use Committee Report No. 7 to authorize the exemption of the lands municipally known in the year 1997 as 1090 Shaw Street, as described herein, from Subsection 50(5) of the Planning Act, R.S.O. c.P.13, as amended;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Subsection 50(5) of the Planning Act, R.S.O. 1990, Chapter P.13, as amended, does not apply to a part or parts of land wholly within any of Blocks A to H inclusive, as described in Schedule "A" to this By-law.
- **2.** Pursuant to the provisions of Section 50(7) of the Planning Act, R.S.O. 1990, c.P.13, and Section 2 of By-law No. 61-95 of the Municipality of Metropolitan Toronto, Section 50(5) of the Planning Act, R.S.O. 1990, c.P.13 ceases to apply to the above-noted lands upon approval of this By-law by the Metropolitan Commissioner of Planning.
