CITY OF TORONTO

BY-LAW No. 355-1998

Respecting fees for environmental health services provided by the Medical Officer of Health.

WHEREAS section 220.1 of the Municipal Act authorizes a municipality to pass by-laws imposing fees or charges on any class of persons;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. In this by-law,

"catering vehicle" means an itinerant food service premise in which no food is prepared other than hot beverages and french fried potatoes;

"City" means City of Toronto;

"Medical Officer of Health" means the Medical Officer of Health for the City of Toronto Health Unit;

"mobile preparation premises" means a vehicle or other itinerant food premise from which food prepared therein is offered for sale to the public.

- **2.** The following fees shall be paid in advance to the City for the following environmental health services provided by the Medical Officer of Health:
 - (a) for each request for information on the status of any land, premises or structures in the City: one hundred and fifty dollars (\$150.00) per municipal address;
 - (b) for each request for reinspection of outstanding deficiencies relating to any land, premises or structures in the City: one hundred and fifty dollars (\$150.00) per municipal address;
 - (c) for each request for information relating to any land, building or structure in the City in respect of liquor licence applications: one hundred and fifty dollars (\$150.00) per municipal address;
 - (d) for each request for an inspection and preparation of documentation relating to the disinterment of a body: one hundred and fifty dollars (\$150.00);

- (e) for each request for an inspection and preparation of documentation for a body to be surrendered to the consulate of the country which is the destination of the deceased: one hundred and fifty dollars (\$150.00);
- (f) for each request for documentation from the Medical Officer of Health stating whether an individual's cause of death was related to a communicable disease: twenty-five dollars (\$25.00);
- (g) for each request for mailing lists maintained by the Medical Officer of Health respecting premises in the City: fifty dollars (\$50.00);
- (h) for each request for inspection of a mobile preparation premises or catering vehicle: one hundred and fifty dollars (\$150.00); and
- (i) for each request for an education program offered by the Medical Officer of Health for food handlers or respecting pool operations: thirty dollars (\$30.00) per person.
- 3. The fees in section 2 are inclusive of G.S.T. where applicable and shall automatically increase on the first day of January in each year by the percentage increase in the All Item Index of the Consumer Price Index (not seasonally adjusted) for the Toronto Census Metropolitan Area, published by Statistics Canada, during the twelve-month period ending on October 1 in the year immediately preceding the rate increase date.
- **4.** Where this by-law conflicts with any other by-laws setting out fees for services provided by the Medical Officer of Health, this by-law prevails to the extent of the conflict.
 - 5. This by-law comes into force on July 2, 1998.
