CITY OF TORONTO

BY-LAW No. 356-1998

To fix the rates for the supply of water and sewage services by the City of Toronto.

WHEREAS the Councils of the former municipalities amalgamated to form the City of Toronto had set various water rates for their water consumers; and

WHEREAS it is necessary and appropriate for the City of Toronto to set water and sewer rates;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Water shall be supplied from the City of Toronto to consumers in the former Borough of East York on the terms and conditions set out in By-law No. 11-90 of the former Borough of East York, as amended, except that Schedule "A" to By-law No. 11-90 of the former Borough of East York shall be and is hereby amended as follows:

(i) In the paragraph entitled "WATER RATES" [4(j)] by striking out the numbers "\$4.64" in the first line thereof and replacing them with the numbers "\$4.73", and by deleting the numbers "\$1.0140" in the second sentence thereof and replacing them with the numbers "\$1.0340".

2. Water shall be supplied from the City of Toronto to consumers in the former City of Etobicoke on the terms and conditions set out in chapter 257-16 A., B., C. and D(1), Article I (Water Rates) of the Municipal Code of the former City of Etobicoke in effect in the former City of Etobicoke for the year 1997 except as amended, at the rates set out in the attached Schedule "A".

3. Water shall be supplied from the City of Toronto to consumers in the former City of North York on the terms and conditions set out in By-law No. 32925, of the former City of North York, except as follows:

- (i) Consumers shall pay \$0.9433 per cubic metre or \$4.28 per 1,000 gallons.
- (ii) The rates to be charged for water used through a fire service with a detector check valve metre for other than firefighting shall be \$30.18 per cubic metre or \$136.96 per 1,000 gallons.

4. Water shall be supplied from the City of Toronto to consumers in the former City of Scarborough on the terms and conditions set out in the resolutions of the former Public Utilities Commission of the City of Scarborough at the rates set out in the 1997 Rates Manual of the former Public Utilities Commission of the City of Scarborough, except as follows:

(i) For the first 22,730.5 cubic metres of water consumption per month, the water rate shall be \$0.7983. For all additional consumption the rate shall be \$ 0.7227 per cubic metre.

5. Water shall be supplied by the City of Toronto to consumers in the former City of Toronto on the terms and conditions set out in Chapter 340 of the Municipal Code of the former City of Toronto except as follows:

- (i) Consumers shall pay \$.88742 per cubic metre of water used or \$4.03430 per 1,000 gallons.
- (ii) The flat rate consumers in the former City of Toronto shall pay the water rates as set out in the attached Schedules "B", "C" and "D" to this by-law.

6. Water shall be supplied by the City of Toronto to consumers in the former City of York in accordance with By-law No. 1259-71 of the former City of York, as amended, except as follows:

(i) Consumers shall pay \$4.61 per 1,000 gallons and the special industrial water rate shall be \$3.54 per 1,000 gallons.

7. Notwithstanding anything to the contrary set out in the by-laws and resolutions of the former area municipalities and the Scarborough Public Utilities Commission with regard to the distribution and supply of water and the provision of sewer services and the rates and charges in relation thereto, commencing July 1, 1998, consumers in the City of Toronto shall pay the fees and charges for the services set out in Schedule "E" attached to this by-law at the rates set out in Schedule "E".

8. Except as otherwise set out in this by-law, all other terms, conditions and fees set out in the by-laws and resolutions of the former area municipalities and the Scarborough Public Utilities Commission with regard to the distribution and supply of water and the provision of sewer services and the fees and charges in relation thereto shall remain in full force and effect.

9. This by-law shall come into force on and take effect from the 1st day of July, 1998.

SCHEDULE "A"

WATER RATES FOR CONSUMERS IN THE FORMER CITY OF ETOBICOKE

- A. Residential and commercial rates, tri-annual billing:
 - (1) Meter services, rate per one thousand (1,000) gallons: four dollars and fifty-six cents (\$4.556). Paid on or before the due date: four dollars and ten cents (\$4.10).
 - (2) Flat rate, single-family: ninety-eight dollars and seventy-one cents (\$98.71).
- B. Hydro substations, tri-annual billing: seventy-one dollars and one cent (\$71.01).
- C. Residential, commercial and industrial rates, monthly billing, metered, rate per one thousand (1,000) gallons: four dollars and fifty-six cents (\$4.556).

Minimum bill of forty-five dollars and fifty-six cents (\$45.56) [ten thousand (10,000) gallons] applies to all commercial and industrial accounts.

- D. Building water rates.
 - (1) Not metered, up to three (3) months not refundable: two hundred and ten dollars (\$210.00).
