

**CITY OF TORONTO**

**BY-LAW No. 477-1998**

**To confirm the second portion of the proceedings of the Council

The Council of the City of Toronto HEREBY ENACTS as follows:

**3.** This By-law, to the extent to which it provides authority for or constitutes the exercise by the City Council of its powers to proceed with, or to provide any money for, any undertaking, work, project, scheme, act, matter or thing which requires an approval in addition to the approval of Council, shall not take effect until the additional approval has been obtained.
