CITY OF TORONTO

BY-LAW No. 591-1998

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cowan Avenue, Dufferin Street, Fleet Street, Fort Rouille Street, Gladstone Avenue, Gwynne Avenue, Jameson Avenue, Melborne Avenue, Peel Street, Spencer Avenue, Springhurst Avenue, Strachan Avenue, Tyndall Avenue.
