BY-LAW No. 616-1998

**To amend By-law No. 92-93, a by-law “To regulate
traffic on roads in the Borough of East York”,
being a by-law of the former Borough of East York.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Lane”, “Both”, “Mortimer Avenue and end north of Floyd Avenue, west of Pape Avenue” and “Lane”, “Both”, “Mortimer Avenue and Memorial Park Avenue” where they appear in Columns 1, 2 and 3 of the said Schedule, the following:

Column 1 Road	Column 2 Side	Column 3 Between	Column 4 Prohibited Times & Days
Lane	East	Mortimer Avenue and the lane south of MacPhail Avenue, west of East York Avenue	Anytime
Lane	Both	Mortimer Avenue and the lane north of MacPhail Avenue, west of Pape Avenue	Anytime

2. Schedule VIII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Lane”, “Both”, “Donora Drive and south end, east of Dawes Road” and “Lane”, “Both”, “Floyd Avenue and north end, west of Donlands Avenue” where they appear in Columns 1, 2 and 3 of the said Schedule, the following:

Column 1 Road	Column 2 Side	Column 3 Between	Column 4 Prohibited Times & Days
Lane	Both	East York Avenue and Pape Avenue, north of MacPhail Avenue	Anytime

3. Schedule VIII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Lane”, “Both”, “Pape Avenue and Donlands Avenue, north of O’Connor Drive” and “Lane”, “Both”, “Plains Road and O’Connor Drive, east of Coxwell Avenue” where they appear in Columns 1, 2 and 3 of the said Schedule, the following:

Column 1 Road	Column 2 Side	Column 3 Between	Column 4 Prohibited Times & Days
Lane	Both	Pape Avenue to the lane west of East York Avenue, south of MacPhail Avenue	Anytime

4. Schedule VIII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Dustan Crescent” and “Eastdale Avenue” where they appear in Column 1 of the said Schedule, the following:

Column 1 Road	Column 2 Side	Column 3 Between	Column 4 Prohibited Times & Days
East York Avenue	East	MacPhail Avenue and Mortimer Avenue	Anytime

5. Schedule VIII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “MacNaughton Road” and “Main Street” where they appear in Column 1 of the said Schedule, the following:

Column 1 Road	Column 2 Side	Column 3 Between	Column 4 Prohibited Times & Days
Macphail Avenue	North	Pape Avenue and the lane west of East York Avenue	Anytime
Macphail Avenue	South	A point 32 metres west of Pape Avenue and the lane west of East York Avenue	Anytime

6. Schedule XII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Lane (west of Donlands Avenue)” and “Leroy Avenue” where they appear in Column 1 of the said Schedule, the following:

Column 1 Road	Column 2 From	Column 3 Time or Days	Column 4 Permitted Direction
Lane	Mortimer Avenue to the lane south of Macphail Avenue, west of East York Avenue	Anytime	Southbound

7. Schedule XII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further

amended by inserting in Columns 1, 2, 3 and 4, between the words “Dustan Crescent” and “Eaton Avenue” where they appear in Column 1 of the said Schedule, the following:

Column 1 Road	Column 2 From	Column 3 Time or Days	Column 4 Permitted Direction
East York Avenue	Macphail Avenue and Mortimer Avenue	Anytime	Northbound

8. Schedule XII of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Logan Avenue” and “Malcolm Road” where they appear in Column 1 of the said Schedule, the following:

Column 1 Road	Column 2 From	Column 3 Time or Days	Column 4 Permitted Direction
Macphail Avenue	East York Avenue to Pape Avenue	Anytime	Westbound

9. Schedule XIX of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Logan Avenue and Gowan Avenue” and “Main Street and Doncaster Avenue” where they appear in Column 1 of the said Schedule, the following:

Column 1 Intersections	Column 2 Stop Streets
Macphail Avenue and the lane west of East York Avenue	On Macphail Avenue

10. Schedule XIX of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4, between the words “Kings Park Boulevard and Woodycrest Avenue” and “Lea Avenue and Airdrie Road” where they appear in Column 1 of the said Schedule, the following:

Column 1 Intersections	Column 2 Stop Streets
Lane west of Pape Avenue and the lane north of Macphail Avenue	On the lane the lane west of Pape Avenue

11. Schedule XIX of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York” as amended, being a by-law of the former Borough of East York, is further

amended by inserting in Columns 1, 2, 3 and 4, between the words “Durant Avenue and Memorial Park Avenue” and “Elswick Avenue and Hackberry Street” where they appear in Column 1 of the said Schedule, the following:

Column 1
Intersections

East York Avenue and the lane north of
Macphail Avenue

Column 2
Stop Streets

On the lane the lane north of Macphail
Avenue

12. This by-law shall come into force on the date of its enactment.
