BY-LAW No. 618-1998

To amend By-law No. 34-93, a by-law “To provide for disabled person parking permit holders”, being a by-law of the former Borough of East York.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule “E” of By-law No. 34-93, a By-law “To provide for disabled person parking permit holders” as amended, being a by-law of the former Borough of East York, is further amended by striking out the following words where they appear in Columns 1, 2, 3 and 4 of the said Schedule:

Column 1 Highway	Column 2 Side	Column 3 Between	Column 4 Time or Days
Cosburn Avenue	South	A point 61.6 metres east of Oak Park Avenue to a point 74.7 metres east of Oak Park Avenue	9:00 a.m. to 11:00 p.m. daily

2. Schedule “E” of By-law No. 34-93, a By-law “To provide for disabled person parking permit holders” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule, between the words “Cosburn Avenue” and “Coxwell Avenue” where they appear in Column 1 of the said Schedule, the following:

Column 1 Highway	Column 2 Side	Column 3 Between	Column 4 Time or Days
Cosburn Avenue	South	A point 68.9 metres east of Oak Park Avenue to a point 74.7 metres east of Oak Park Avenue	Anytime

3. Schedule “F” of By-law No. 34-93, a By-law “To provide for disabled person parking permit holders” as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule, between the words “Coleridge Avenue” and “Gower Street” where they appear in Column 1 of the said Schedule, the following:

Column 1 Highway	Column 2 Side	Column 3 Between	Column 4 Time and Days
Cosburn Avenue	South	A point 61.6 metres east of Oak Park Avenue to a point 68.9 metres east of Oak Park Avenue	5:00 p.m. to 11:00 p.m. Wednesday, 8:00 a.m. to 11:00 p.m. Saturday, 8:00 a.m. to 11:00 p.m. Sunday

4. This by-law shall come into force on the date of its enactment.
