BY-LAW No. 643-1998

**To amend City of York By-law No. 196-84,
being a By-law “To Regulate Traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3, and 4 of said Schedule the following:
