**CITY OF TORONTO**

**BY-LAW No. 684-1998**

**To amend the former City of Toronto Municipal Code Ch. 400,  
Traffic and Parking, respecting Prescott Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No parking certain times) in §400-76, the following in alphabetical order by street name:
