BY-LAW No. 714-1998

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, Schedule XXVI (Permit Parking), by adding a new Part YY respecting Miller Street and a new Part ZZ respecting Shaftesbury Avenue, Summerhill Avenue, Summerhill Gardens, Woodlawn Avenue.

WHEREAS in order to provide for permit parking between the hours of 12:01 a.m. to 6:00 p.m. Monday to Saturday and 12:01 a.m. to 7:00 a.m. Sundays and Public Holidays and 2:00 a.m. and 11:00 a.m. daily, on Miller Street, Shaftesbury Avenue, Summerhill Avenue, Summerhill Garden and Woodlawn Avenue respectively, it is necessary to create a new Part YY and a new Part ZZ of Schedule XXVI (Permit Parking) of former City of Toronto Municipal Code Ch. 400, Traffic and Parking.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Ch. 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting in §§400-38B and 400-38D(1) “WW or XX” and replacing it with “WW, XX, YY or ZZ”.

B. By inserting in §§400-38E the following:

“Part YY	12:01 a.m. to 6:00 p.m. Monday to Saturday and 12:01 a.m. to 7:00 a.m. Sunday and Public Holidays
Part ZZ	2:00 a.m. to 11:00 a.m.”

C. By deleting in §400-38G(2)(a) “WW and XX” and replacing it with WW, XX, YY and ZZ”.

D. By deleting from Part F in Schedule XXVI (Permit Parking) in §400-79, the following in alphabetical order by street name:
