BY-LAW No. 718-1998

To amend former City of Toronto Municipal Code, Chapter 400, Traffic and Parking, respecting 30 kilometre per hour speed limits on streets with Traffic Calming measures in effect and respecting Boon Avenue, Cowan Avenue, Earlscourt Avenue, Glengrove Avenue, Harvie Avenue, Logan Avenue, Nairn Avenue, River Street, Springhurst Avenue, Spruce Street, Wellington Street West and Yarmouth Avenue.

WHEREAS by the enactment of By-law Nos. 1997-0456, 1997-0461, 251-1998, 1997-0457, 592-1998, 1997-0459, 1997-0462 and 1997-0402 by the former City of Toronto Council and new City of Toronto Council, Traffic Calming measures were authorized to be installed on Boon Avenue, Cowan Avenue, Earlscourt Avenue, Glengrove Avenue, Harvie Avenue, Logan Avenue, Nairn Avenue, River Street, Springhurst Avenue, Spruce Street, Wellington Street West and Yarmouth Avenue, and the speed limit reduced to 30 kilometres per hour once the Traffic Calming measures were in place.
