## BY-LAW No. 739-1998

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Coe Hill Drive, Dovercourt Road, Granby Street, Mackenzie Crescent, Scollard Street, St. Clarens Avenue.
