## **BY-LAW No. 800-1998**

## To authorize the removal of certain trees growing on the highways of the Municipality.

WHEREAS the *Municipal Act*, R.S.O. 1990, Chapter M.45, Section 312, subsection 4(e) provides that the Council of every municipality may pass by-laws causing any tree planted upon a highway within the municipality to be removed when considered necessary in the public interest; and

WHEREAS it is considered necessary in the public interest to cause the trees hereinafter designated, growing on the highways of the municipality, to be removed;

Now therefore the Council of the City of Toronto HEREBY ENACTS as follows:

**1.** The Commissioner of Economic Development, Culture and Tourism be and he is hereby authorized and instructed to cut down and remove, or cause to be cut down and removed, the trees standing in the following highways,

Appleton Ave. (22)	One (1) Basswood tree, standing on the West side of Appleton Ave., abutting Lot 11, Plan 1536 on which is situated house #22.
Reason for removal:	Trunk is hollow.
Edmund Ave. (7)	One (1) Tree of Heaven, standing on the South side of Edmund Ave., abutting PT Lot 78, Plan M393 on which is situated house #7.
Reason for removal:	Tree is 1/2 dead and rotten at base.
Hillary Ave. (30)	Two (2) American Elm trees, standing on the North side of Hillary Ave., abutting Lot 729, Plan 2245 on which is situated house #30.
Reason for removal:	Trees are dead.
John St. (241)	Two (2) Norway Spruce trees, standing on the South side of John St., abutting Lot 23, Plan 2115 on which is situated house #241.
Reason for removal:	Tree is in poor/fair condition. Branch tops are into hydro wires. Tree is badly disfigured.
Lauder Ave. (317)	One (1) Norway Maple tree, standing on the East side of Lauder Ave., abutting S PT Lot 13, Plan 1559 on which is situated house #317.

Trowell Ave. (1)	One (1) White Oak tree, standing on the South side of Trowell Ave., abutting PT Lots 425 to 430, Plan 1896 on which is situated house #1.
Reason for removal:	Tree is dead.
William St. (135)	One (1) Sugar Maple Tree, standing on the South side of William St., abutting Lot 8, Plan M465 on which is situated house #135.
Reason for removal:	Tree was damaged in storm.
William St. (74)	One (1) Sugar Maple tree, standing on the North side of William St., abutting PT Lot 9, Plan 182 on which is situated house #74.
Reason for removal:	Tree is dead.
