BY-LAW No. 819-1998

To confirm the proceedings of the Council at its meeting held on the 28th, 29th and 30th days of October, 1998.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The action of the Council on the 28th, 29th and 30th days of October, 1998, in respect to each recommendation contained in the Reports of the Standing Committees, Community Councils and other Committees, as follows:

of the Toronto Transition Team, and
Joint Report No. 1 of The Urban Environment and Development Committee and
The Economic Development Committee,

up to and including the enactment of this Confirmatory By-law at 2:36 p.m. this day, and in respect of each motion, resolution and other action passed and taken by the Council at its said meeting, including the enactment of any previous Confirmatory By-laws in respect of the said meeting, is hereby adopted, ratified and confirmed.

2. The Mayor and the proper officers of the City are hereby authorized and directed to do all things necessary to give effect to the said action or to obtain approvals where required, and except where otherwise provided, the Clerk and Treasurer are hereby authorized and directed to execute all documents necessary in that behalf and to affix the corporate seal of the City to all such documents.

3. This By-law, to the extent to which it provides authority for or constitutes the exercise by the City Council of its powers to proceed with, or to provide any money for, any

undertaking, work, project, scheme, act, matter or thing which requires an approval in addition to the approval of Council, shall not take effect until the additional approval has been obtained.
