BY-LAW No. 927-1998

To adopt Amendment No. 470 of the Official Plan for the City of North York.

WHEREAS authority is given to Council by the Planning Act, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and whereas Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the Planning Act;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Amendment No. 470 to the Official Plan of the City of North York, consisting of the attached text and schedules, is hereby adopted.
- 2.** This By-law shall come into force and take effect on the day of the final passing thereof.

PREFACE AND EXPLANATORY NOTES

TO AMENDMENT No. 470

TO THE OFFICIAL PLAN OF THE

CITY OF NORTH YORK

LANDS AFFECTED BY THIS AMENDMENT

This amendment concerns the lands located on the south side of Lorraine Drive east of Blakeley Road. The municipal address is 29 Lorraine Drive.

EFFECT OF AMENDMENT

The effect of this amendment would be to redesignate the lands to Local Open Space (LOS) in keeping with the intended use as parks and open space.

PUBLIC MEETINGS

The North York Community Council considered Amendment Application UDOZ-98-24 at a statutory public meeting held on December 9, 1998, after written notice of such meeting had been sent to all persons assessed in respect of land and to all tenants within 120 metres of the subject lands. It was North York Community Council's decision to recommend approval of the application.

A meeting to consider this matter was held by Council of the City of Toronto on December 16 and 17, 1998. Council adopted the recommendation of the North York Community Council to approve the application.

On December 17, 1998, Council enacted By-law No. 927-1998.
