CITY OF TORONTO

BY-LAW No. 951-1998

To amend Scarborough Zoning By-laws, the Employment Districts Zoning By-law No. 24982 with respect to the Knob Hill Employment District and Zoning By-law No. 10048, with respect to the Eglinton Community By-law.

WHEREAS authority is given to Council by Section 34 of the Planning Act, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and whereas Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the Planning Act;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Amendments to By-law No. 24982, the Employment Districts By-law (Knob Hill District):

- 1.1 The provisions of By-law Number 24982, shall not apply to the land shown outlined on the attached Schedule "1".
- 2. Amendments to By-law No. 10048, the Eglinton Community By-law:
 - 2.1 Schedule "A" is amended by adding the land shown on the attached Schedule "1" together with the following letters and numerals:

CC - 40B - 88 - 180 - 323

2.2 Schedule "B", **PERFORMANCE STANDARDS CHART**, is amended by adding the following Performance Standards:

MISCELLANEOUS

88. Patios, roof overhangs, canopies and supporting columns may be built into the **street line**.

PARKING

180. Minimum 5.0 parking spaces per 100 m² of **gross floor area** for personal service shops and retail stores, including ancillary restaurants.

3. Schedule "C", **EXCEPTION LIST**, is amended as follows:

- a) By adding Exception Number 13 as follows:
 - 13. On those lands identified as Exception 13, the following provisions shall apply, provided that all other provisions of the By-law not inconsistent with this Exception, shall continue to apply:
 - a) The following uses are permitted:
 - retail stores, personal service shops, restaurants
 - banks, business and professional offices
 - b) The following ancillary uses are permitted in conjunction with a retail store:
 - **open storage** and display of goods within 30 m of the **main wall** and within 210 m of the west property line.
- b) Exception Numbers 13 and 14 are added to the lands identified with a heavy black line on the accompanying Schedule "2" map.



LOT 22


