BY-LAW No. 56-1999

Appointments to Greater Toronto Services Board.

WHEREAS the Greater Toronto Services Board Act, 1998, requires the Council of the City of Toronto to appoint ten of its members as members of the Greater Toronto Services Board; and

WHEREAS the Greater Toronto Services Board Act, 1998, provides that the Council of the City of Toronto may appoint alternates for the members of the Board who are appointed by the Council and an alternate for the Mayor of the City of Toronto; and

WHEREAS the Greater Toronto Services Board Act, 1998, provides that the members of the Board representing the City of Toronto shall have four additional votes, distributed among the members as determined by the Council of the City of Toronto, with respect to matters set out in Part II of the Greater Toronto Services Board Act, 1998, and in elections of the chair of the Board;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The following Members of Council are appointed as members of the Greater Toronto Services Board and their alternates, in addition to Mayor Lastman, who is a member of the Greater Toronto Services Board by virtue of his office:

2. The following Member of Council is appointed as the alternate to Mayor Lastman:

Councillor Case Ootes.

3. The term of office for the City of Toronto appointees to the Greater Toronto Services Board shall expire on November 30, 1999.

4. The additional four votes which the City of Toronto is granted for matters set out in Part II of the Greater Toronto Services Board Act, 1998, and in elections of the Chair of the Board, are allocated to Mayor Lastman; and, in the absence of Mayor Lastman, these additional four votes are allocated to the Mayor's Alternate, Councillor Case Ootes.

5. This by-law is deemed to have come into force on December 19, 1998.
